New eLearning Course Encourages Student Success via Quality Advising

Just in time for the fall semester, the Center for Excellence in Teaching and Learning (CETL) has launched a new Advisor Development eLearning course. The course guides participants in five areas of core knowledge: Advising at UNI, Advisor Toolbox of Relational Skills, Referrals and Forms, Undergraduate Degrees and the Liberal Arts Core, Reading an Advisement Report, and Navigating the SIS.

The Office of Academic Advising's *Referral Resources: Directory of Curricular and Career Information*, available on the [advising website](#), is another key means to guide anyone who offers advice to UNI students.

Within *Referral Resources* is contact information organized by department ("Who advises first-year students in Communication Sciences and Disorders?" "Who should a student contact regarding questions about a focus on Dentistry?"), directories for offices in Academic Affairs and Student Affairs, and a section devoted to referral resources "by problem or interest."

This section is especially specific, with its contact information ranging from counseling needs, to Special Community Services, to reserving

special populations, and cultural competency for advisors.

While anyone can be registered into the course and use modules of interest, the course is also a part of a new Advising Certificate, sponsored by the CETL.
