**Karen Forrest, Ph.D., CCC-SLP**, is a Professor at Indiana University where she teaches courses in Motor Speech Disorders, Instrumental Analysis of Speech and Language, and Techniques for Graduate Research. Her research interests include deficits associated with developmental and neurological disorders. Karen earned her undergraduate degree from Washington University and her Ph.D. from the University of Iowa.

**Ken Bleile, Ph. D., CCC-SLP**, is a Professor at the University of Northern Iowa. In recent years he has also served as a visiting scholar in the University of Anatolia, Turkey, in the Ministry of Health, Singapore, in Herten University, Saint Petersburg, Russia, and in the University of Canterbury, New Zealand. Dr. Bleile served as an Associate Editor for the *American Journal of Speech-Language Pathology* and has published numerous articles and books about speech development, pediatric head injury, and communication disorders in children.

**Alex Johnson, Ph.D., CCC-SLP**, is a Professor and Department Chair at Wayne State University. His research interests include Neurogenic Communication Disorders, Stuttering, and Language and Literacy. Dr. Johnson is the past President of the American Speech-Language and Hearing Association. He earned his Ph.D. from Case Western Reserve University. He has published numerous research papers.

**Todd Bohnenkamp, Ph. D, CCC-SLP**, is an Assistant Professor at the University of Northern Iowa. He received his B.A. from the University of Iowa and his M.A. from the University of Northern Iowa and earned his Ph.D. from Indiana University. Dr. Bohnenkamp teaches courses in: Anatomy and Physiology, Neuroscience, and Head and Neck Cancer. His research interests are in the areas of laryngectomy, respiration and its implications for speech, as well as voice disorders.

**Carlin Hageman, Ph.D., CCC-SLP**, is a Professor of Speech-Language Pathology at the University of Northern Iowa (UNI). He has been a NSSLHA advisor for a total of 24 years and was selected as the Executive Director of NSSLHA beginning in 2004. Presently, he is the ISHA Vice President for Government, Colleges and Universities. He has a variety local, national and international presentations and publications in aphasia, motor speech disorders, and the application of motor learning principles to therapy for speech disorders.

**Chris Neuhaus, M.S., M.L.I.S.**, is the Library Instruction Coordinator and an Associate Professor at the University of Northern Iowa. He earned his M.S. in Geological Sciences at the University of South Carolina. He also holds a Masters degree in Library and Information Science.

**Joy Hesse, M.A., CCC-SLP**, is a Speech-Language Pathologist and voice therapist at the ENT Clinic of Iowa, P.C. She has 15 years experience and specializes in the evaluation and treatment of voice problems—particularly those of professional voice users such as singers, choral directors, teachers, lawyers and others. Ms. Hesse has a particular interest in voice problems due to head and neck cancer.

**Simon Wright, M.D., Ph.D.**, is a Physician at the ENT Clinic of Iowa, P.C. Dr. Wright specializes in the medical and surgical treatment of ear, nose and throat disorders. His special areas of interest include pediatric otolaryngology, laryngology and professional voice, thyroid and parathyroid surgery, and cancer of the head and neck. He is a leader in the application of robotic surgery techniques to head and neck surgery. Dr. Wright is also a scientific reviewer for "The Laryngoscope."

**Kathy Jakielski, Ph.D., CCC-SLP**, is an Associate Professor and Program Director in Communication Sciences and Disorders at Augustana College in Rock Island, Illinois. She has over twenty years of clinical experience working with children and adolescents with severe speech impairment, including CAS. Dr. Jakielski worked clinically for nine years in a variety of settings, including a university clinic, public schools, Head Start, private practices, and diverse hospital settings, and then earned her doctorate at the University of Texas in the area of early normal and disordered speech acquisition focusing on CAS. Dr. Jakielski is a professional advisory board member of the Childhood Apraxia of Speech Association of North America.

**Tricia Zebrowski, Ph. D., CCC-SLP**, is an Associate Professor at the University of Iowa. She is a Fellow of the American Speech-Language and Hearing Association. She is also a Board Recognized Fluency Specialist. Her clinical and research areas of interest are with stuttering, with particular emphasis on children who stutter. Dr. Zebrowski has authored many research and clinical papers, videos, and a manual for stuttering intervention.
