No automatic "cut-off" point...

Dean Lang explains Admission Policies

(Editor's Note: In the past year, partly as a result of moves to set the sights of scholastic standards at ISTC a bit higher, much misunderstanding has developed concerning admission requirements at ISTC. To give alumni an accurate report, we here present a statement from Dr. William C. Lang, new dean of instruction at the College.)

As a professional college for the education of teachers and other school personnel, the Iowa State Teachers College is obligated to consider scholarship, health, personality, character, and qualities of potential leadership of an applicant for admission.

The college believes all its graduates should not only be effective teachers, but also active citizens exercising leadership in civic and educational life. Hence it requires all students to complete a program of general education, to acquire some depth of knowledge in at least one intellectual discipline, to understand the teaching-learning process, to grasp the role of the school and the teacher in the community, and to demonstrate ability in the classroom.

On the basis of the preceding philosophy, the college has had a selective admissions procedure for over a decade.

In determining an applicant's eligibility for admission, officials of the college consider the following questions:

1. Does the applicant have personal characteristics that are acceptable in a prospective teacher?
2. Has the applicant been recommended for admission to the college by a high school superintendent, principal, counselor, or teacher.
3. Does the applicant have the ability, desire, and maturation that indicates

probable academic success in college?

4. Is the applicant interested in teaching as a possible vocational choice?
5. Will the applicant have the support of his parents while attending college?

General admission standards are determined by the State Board of Regents and approved by the Attorney General of the State of Iowa. Specific regulations are determined by the college faculty.

Freshman Admission Requirements

1. If a student ranks in the upper one-half of his high school graduating class, his standardized test scores indicate probable success in college, and his health certificate from his local physician is approved by the Director of Student Health Service at the college, he is usually admitted by the Registrar of the college as soon as the necessary admission material is submitted.

2. Applications from students who rank in the lower one-half of their graduating class are examined by an admissions committee. After the committee has examined the high school record including the rank in class, standardized test scores, recommendations from high school officials and the health certificate, it may or may not request a personal interview with the applicant depending upon the record and circumstances. The committee may (1) suggest that the student enroll for a tryout period during a summer session, (2) admit the applicant or (3) deny admission.

Every effort is made to admit all students who show reasonable promise of doing college work successfully and becoming teachers who are worthy to be trusted with the education of Iowa's young people.

Preliminary Plans Approved...

ISTC to Begin 5 Construction Projects

Architects have been selected and preliminary plans approved for five major construction projects at Teachers College.

The five projects are all results of last year's \$2,572,250 appropriation by the 58th General Assembly for nine items of capital improvement at the college.

Morgan and Associates of Burlington have been selected as architects for the \$315,000 Health Service Building. The State Board of Regents has approved preliminary plans and specifications, and detailed drawings are nearly completed.

The building will be located on a parking lot north of the Men's Gymnasium. Facilities will include eight patient rooms, living quarters for nurses, and X-ray, laboratory, and drug rooms.

Progress on the Music Education Building, for which \$1,155,000 was allocated, has been the approval by the Board of Thorson and Brom of Waterloo as architects and approval of preliminary plans.

Morgan and Associates have also been selected as architects for the \$209,250 Arts and Industries Building addition.

Preliminary plans and specifications have been approved.

The addition will be connected to the west side of the main building. It will contain a new metal shop, drafting room, ceramics laboratory, art office, driver education facilities, and some classroom space.

The Board has appointed Brown Engineering Company, Des Moines, to plan heating plant improvements, for which \$570,000 was provided. The contract has been let for purchase of a large new boiler from the Bros Company, Minneapolis, to replace two old smaller boilers.

Architects for putting in fire escapes and remodeling the stage in the Auditorium Building will be Grow and DeVoe of Cedar Falls. Preparation of plans is proceeding and construction is expected to begin in the summer. Grow and DeVoe will also be architects for an addition to the Greenhouse.

One hundred twenty-six acres of farmland west of Highway 57 were purchased for future expansion of the college with some state funds appropriated for land purchase and some funds from dormitory accounts.

ACCIA to View Problems of Nuclear Age

"New World Structures for the Nuclear Age" will be the theme of this year's All-College Conference on International Affairs to be held May 5-8, according to Dr. George Poage, associate history professor and faculty chairman.

Improvement in communications among nations, world-wide economic structures, and the role of scientists in world affairs will be discussed by "prominent authorities with a far-ranging view of each field in respect to the problems of the nuclear age," Dr. Poage said.

"Instead of picking out one problem area in international politics such as the Mid-East or Germany as we have in the past," he said, "this time we hope to examine the possibilities of new ways to solve world-wide problems."

Dr. Poage explained "new world structures" by saying that the United Nations is a world structure in the political realm, while the conference will attempt to explore possible world structures in other realms.

Selection of the three speakers is still pending, Dr. Poage said. Another still-tentative proposal is an invitation to the delegates to the United Nations to attend the conference as observers.

"It has been felt during our previous conferences that foreign diplomats got a great deal out of just visiting this part of the country," Dr. Poage said. "They say the Midwest is a part of America they have heard about as being typically American but have never encountered on the coasts."

For this reason, he said, it was felt that members of the U.N. might like to visit this area, without having to appear on the program of the conference.

Bertha L. Patt dies; Served TC 53 Years

Bertha L. Patt, 91, Professor Emeritus at Iowa State Teachers College since 1938, died December 17, 1959, at the Lutheran Home in Cedar Falls. She had been ill for some time.

Miss Patt began her 53 years of service at the college in 1895, when it was still known as the Iowa State Normal School. She held the position of professor of art and manual arts, and continued part-time teaching until 1948.

Born in Tiskilwa, Illinois, July 10, 1868, she attended high school and normal school in Dexter, Iowa, and studied art at the Des Moines Academy of Art, the Art Students League of New York, and the Art Institute of Chicago.

She taught art in the public school in Nevada in 1888, at Decorah in 1890, and was Supervisor of Art in Butte, Montana, in 1892.

She was a member of the Iowa State Teachers Association, the National Education Association, the College Art Association, the Western Arts Association, the International Federation for Art Education, and the American Federation of Arts.

When Miss Patt joined the staff in 1895 the Iowa State Normal School had a faculty of thirty-eight instructors, and only four buildings to house its eight hundred students.

Miss Patt received the Iowa State Teachers College Alumni Service Award in June, 1958.

Funeral services were held at Dahl's Funeral Home in Cedar Falls.

Cold and blustery now, but . . .

College Plans Ahead for Summer Sessions

That may look to you like snow out there, but some seventeen institutes, workshops, conferences, and tours, in addition to the regular summer session of classes, are being scheduled anyway for the busy summer at Iowa State Teachers College.

The regular 8-week summer session will run from June 13 through August 5, with a post-session scheduled for August 8 through 19. Four other programs will also run the full length of the summer session, including the Mathematics Institute, the Air Age Education Workshop, the Asian Institute, and the Junior High School Mathematics and Science Program.

The National Science Foundation has provided a grant of \$69,000 to enable sixty elementary, junior, and senior high school mathematics teachers to receive \$600 stipends to attend the **Mathematics Institute**. The money will provide for the stipends, dependents' allowances and other expense money, and instructors' salaries and administrative costs of the program.

The sixty teachers will study ways to up-grade and up-date their teaching techniques. Special emphasis in the program will be on junior high mathematics teachers. The program is directed by Dr. Irvin Brune, mathematics professor.

The Third Air Age Education Workshop will be conducted under the direction of Dr. William Dreier, associate education professor. The workshop, which will carry four hours credit, will be attended by elementary, junior and senior high school teachers. They will study astronautics, astronomy, science, and space. The Iowa Aeronautics Commis-

sion will provide money for some stipends for those attending.

The first **Summer Institute of Asia** will also be designed for elementary, junior and senior high school teachers who want to increase their knowledge and back-

Esther Boehlje Dead After Long Illness

Miss Esther Boehlje, professor of education, passed away December 11, 1959, at Mercy hospital, Mason City, after an extended period of illness.

Miss Boehlje joined the staff of Iowa State Teachers College in 1937. During 1944-48, she taught at Indiana University, returning to TC that fall. Prior to coming to the college she had taught in the public schools at Mason City, Cherokee, Ottumwa and Lake Mills and at East Tennessee State Teachers College and Illinois State Normal University.

Miss Boehlje received her B.A. degree from Iowa State Teachers College in 1931; her M.A., from the State University of Iowa in 1934, and the Ed. D. degree from the University of Indiana in 1952.

President J. W. Maucker, in a letter to the faculty, said:

"Dr. Boehlje was an exceedingly capable and respected member of the ISTC staff. She always exhibited a kindly interest in the individual student and will long be remembered for her patience and graciousness and for her remarkable courage in the face of serious illness."

Funeral services were held December 14 at the Sheffield, Iowa, Grace Baptist church. Surviving are her parents, two brothers and one sister.

Fine Teams in Prospect...

Spring Sports Get Under Way Soon at TC

Spring sports at ISTC get underway in April when track, baseball, tennis and golf take over the athletic spotlight.

Coach Art Dickinson can look forward to another fine track season, with 18 lettermen sprinkled through a 40-man squad.

Top returnee is Max Huffman, who led the cinder team in scoring last spring with 106 points. The all-around star competed in the broad jump, low hurdles, high jump, sprints and javelin to ring up his total.

Huffman, a star halfback during the football season, broke the Panther broad jump record with a leap of 23 feet, 4 inches.

Other top vets back are vaulter Jim Duea, middle distance man John States, and distance ace Bob Conway. Coach Dickinson can also look for help from some good sophomore candidates.

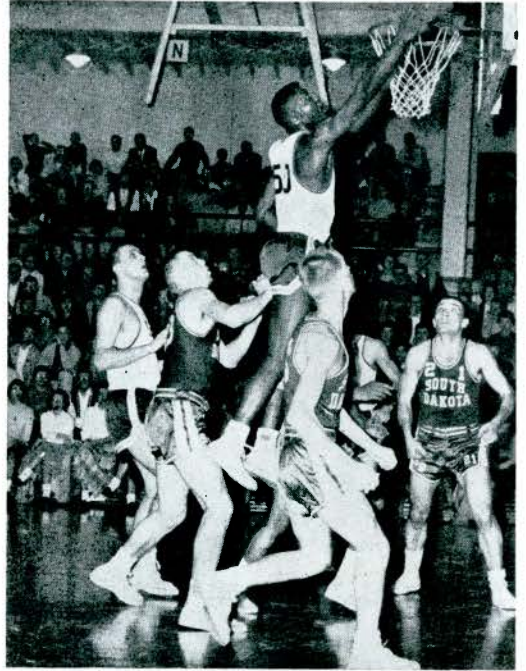
The cindermen also have an ambitious indoor season ahead, starting the middle of February.

The baseball team, which enjoyed one of its best seasons in history last year, (11 wins, 3 losses), has only six lettermen back.

But Coach Mon Whitford, who did a tremendous rebuilding job last spring, could have another fine campaign if some key positions can be filled.

Mon can count on a pair of top pitchers in lefties Kent Folsom and Dave Ray. He also has veteran outfielders Lyle Thompson and Dennis Olejniczak in camp. Ron LaFrentz returns at first base and Jerry Newton at third.

Trouble spots for the Panthers will be down the middle — shortstop, second base, and catcher. If Whitford can adequately fill these positions, the Panthers

will have a good shot at their third straight southern division conference title, and their second National Collegiate playoff birth in three years.

The tennis and golf teams, which have dominated conference tournaments the past several years, both have two lettermen back.

Coach Jim Clark's golfers, who enjoyed a 4-1 season and grabbed the league's championship trophy for the second straight year, will be led by Tom Bartelsson and John Schutte.

Bill Koll's tennis team has Danny Staggs, unbeaten last year, and Ron Lough back. The net team was 6-1 last spring, but heavy rains thwarted their efforts to defend their loop championship and the tourney was called off.

Fond hope becomes reality...

FM Station OK'd by Board of Regents

Permission to apply for a construction permit for an FM educational radio broadcasting station to be operated by Iowa State Teachers College was recently granted by the State Board of Regents.

Completion of the project depends on the granting of a construction permit by the Federal Communications Commission and provisions of funds from voluntary contributions to the I.S.T.C. Foundation for purchase of the transmitter. Following completion of construction, the college can apply to the FCC for a broadcast license.

Recommendations from the college were that the station be similar in nature to those operated by the State University of Iowa and Iowa State University. The FM signals from these stations are too weak to be consistently received in the Waterloo-Cedar Falls area. The 10-watt transmitter planned at the Teachers College would broadcast for about a 10 mile radius.

The station would be strictly educational, and would concentrate on broadcasts of classical music from the college's Record Library of about one thousand 78-r.p.m. records and two thousand LP selections. Music from these records would be supplemented by "live" broadcasts of concerts and recitals presented in the college auditorium.

It was suggested that the college ask the FCC for a minimum broadcast schedule of from 5 p.m. to 8 p.m. Sunday through Friday. Special programs on Saturdays and at other hours of the day could be broadcast, according to FCC regulations concerning such stations.

Other programs suggested were a 15-minute broadcast each evening of news about the college and announcements of college events.

The college also suggested use of tapes from the National Association of Educational Broadcasters (NAEB), which supplies discussion programs such as "Georgetown University Forum" to colleges and universities which operate their own radio stations.

College officials stressed that there would be no commercial announcements on the station, a restraint clearly imposed on all educational FM stations by the FCC.

Social Science Class In Europe in 1961

The Third Social Science Seminar in Europe is scheduled for the summer of 1961. Dr. Howard V. Jones, associate professor of history and Dr. Louis Bultena, professor of sociology, have been appointed directors of the seminar. Planning for the tour has started.

The Second Seminar, in 1958, featured several weeks of study at Oriel College, Oxford University, with a staff of Oxford professors. This was preceded by a tour of England and Scotland, and followed by an extensive tour of Western Europe. Although plans for the 1961 Seminar are still tentative, a somewhat similar format will probably be followed. It is hoped that the 1961 tour may be able to visit Russia, and also that it may spend two weeks at the University of Vienna in Austria.

The Seminar awards six semester hours of graduate or undergraduate credit, and is open to students of junior standing or higher.

Persons who may be interested in the 1961 tour are urged to contact Dr. Jones or Dr. Bultena as soon as possible. The number of persons who can be accepted for the tour is limited.

Not all blame on students...

Cheating Partly the Fault of Teachers

Two research and testing experts at Iowa State Teachers College, commenting on the recent nation-wide attention given to student cheating, said at least some of the blame for student cheating should be given to teachers who may actually tempt students to cheat by the way they conduct their courses and tests.

"Some instructors may make their students feel forced to cheat by too strict grading and by placing too much emphasis on determining the final grade on the basis of one final examination," said Dr. Herbert Silvey, director of research at ISTC.

"Students are tempted to cheat also when an instructor uses the same test year after year," said Dr. Gordon Rhum, co-ordinator of research. "It's almost hopeless to keep a strict guard on such a test because word gets around among students when an instructor has used the same test for many years."

The two men suggested several ways in which teachers can discourage cheating on tests.

"Probably the most important thing is for the teacher to change the test every time he gives it, said Dr. Rhum. "That way the test questions can be discussed after the test and made a learning device, which is the proper function of a test."

"If teachers feel they don't have time to construct new tests every semester, maybe they should be given the extra time," said Dr. Silvey. "I think, though, that constructing new tests should be considered part of the teacher's normal work in a semester. and he should plan on making time for them. Constructing new tests all the time also encourages introducing new materials into the course

continually instead of teaching it the same way year after year."

Dr. Silvey pointed out that teachers can further discourage cheating by giving two or three tests and some written work during the semester instead of placing all the emphasis on one final test. Often the single test, through fear, makes the student feel he must rely on cheating.

"The teacher should also be present while the test is being given," Dr. Rhum said. "This not only discourages cheating, but is helpful to the students when the inevitable questions arise."

Dr. Silvey said "There has been a growing tendency for teachers to make use of generally accepted statistical test analyses which tell them whether their tests and questions are well-constructed and fair. This points up the genuine concern of teachers to make the best possible tests, and should be encouraged."

Both men felt that students who cheat are definitely in the minority. "Most stories about student cheating are blown up all out of proportion because they sound sensational, while the fact that the majority of students don't cheat is not so interesting," Dr. Silvey said.

Jim Daman, Humboldt, editor of the *College Eye*, has been named a regional winner in an editorial-writing contest sponsored by the Student League of the University of Havana, Cuba.

Daman's editorial was on "The Future of Hemispheric Cooperation."

Fees to be Higher At TC Next Year

An increase of ten dollars a semester in student fees at Iowa State Teachers College has been approved by the State Board of Regents. Also approved was a twenty to twenty-four dollar yearly increase in dormitory rates for the 1960-61 year.

"In view of rising costs and the desirability of making salary adjustments to meet competition for staff," President J. W. Maucker said, "we felt it necessary to ask the Board for an increase in student fees."

The three percent increase in dormitory board and room rates was also necessary to meet rising costs of operation, he said.

The new student fees will go into effect Sept. 1, 1960. Resident undergraduate fees will go from \$100 a semester to \$110, with corresponding increases in fees for summer session and partial loads.

Graduate student fees will also go up ten dollars at the same time, from \$115 to \$125. Student Aid Scholarships will carry a corresponding larger reduction in fees.

Campbell Hall, upperclass women's dormitory, will undergo the largest board and room increase, from \$600 a year to \$624. Bartlett and Lawther women's dormitories and Seerley-Baker men's dormitory will increase from \$590 to \$610, and men's Stadium Hall rates will go up from \$574 to \$594.

120 Get Degrees In Winter Graduation

Some 120 students received degrees from Iowa State Teachers College following the fall semester, according to Registrar Marshall Beard.

Last year the college awarded 345 degrees at the June commencement and 177 at commencement exercises following the summer session.

Six-Year Degree Being Planned

Iowa State Teachers College has been given general authorization to offer a sixth-year Specialist in Education (Sp. Ed.) degree by the State Board of Regents.

The new degree will be based on at least thirty hours of study beyond the master's degree. Specific programs for major areas of study leading to the degree must be approved by the Board before the college can begin the program.

"The Board action does not mean that we can start offering this degree right away," said President J. W. Maucker. "We will need to work out the programs and secure Board approval before they become effective."

The sixth year degree is expected to provide administrative, supervisory, and specialized school personnel an opportunity to secure additional professional education.

It is not the equivalent of a Ph.D. degree.

Spring Reunion to Honor Classes of '00, '10, '35

"Hobble, Gobble, Razzle. Dazzle, Zip, Boom, Bah! Seniors, Seniors, Rah! Rah! Rah!"

This was the class yell of the class of 1910, the 50-year honor class at the 77th Annual Spring Reunion of alumni and faculty to be held on the day of the college Baccalaureate, Sunday, June 5.

Also to be honored at the reunion are the classes of 1900 and 1935. The honor classes, as well as alumni from other classes, will attend a luncheon at 12:30 p.m. in the Commons. Donald Barker, president of the Alumni Association, will preside at the luncheon, and President J. W. Maucker will speak.

Also at the Sunday luncheon, Alumni Service Awards will be presented for out-

standing service to the Alumni Association and the college. Group pictures of the honor classes will be taken before the luncheon.

Anson Vinall, '35, is chairman of the general reunion committee.

Members of the class of 1910 will be invited to a class reunion dinner June 4, at which the fifty-year medals will be presented. At the time of their graduation in 1910 the class took pride in the fact that it received more 4-year degrees than any previous class.

Another event which stood out in the history of the class was the attempt to organize the class as juniors. The juniors waged a heated battle with the class of

naught nine, but due to President Seerley's opposition to class organization other than seniors, the organization had to disband until they reached senior status.

Abram, who was editor of the Old Gold, now living at 1931 Main St., Cedar Falls; Sybil Lincoln, class secretary, now Mrs. W. L. Cohagan, business manager of the Normal Eye, lives at 1454 W. 4th, Waterloo.

Falls, Minnesota; David Grant, president of the Student Council, now chairman of the Department of English and Speech at California State Polytechnic College in San Luis Obispo, Calif.; Marcella Gutz, president of Bartlett Hall Council, now Mrs. Audrey Gibbs of Greenfield, Ia.; James Curtis, president of Men's Union, now director of speech at the State University of Iowa; and Mary Lou Mitze, president of Women's League and Representative Woman, 710 S. ground in Asian civilization and culture. Dr. Nathan Talbott, assistant professor of government, will direct the Institute.

The program will offer a number of special lectures and exhibits which will be open to the public, as well as the regular schedule of courses. The Asia Society Inc. of New York, the Japan Society of New York, and the Asia Foundation, San Francisco, have combined to award the program a small grant to be used for scholarships for outstanding applicants.

The **Junior High School Mathematics and Science Program** will be conducted for outstanding junior high mathematics and science students. The program will also provide teachers with a chance to observe classes for the exceptional students. The program is under the direction of Dr. Ross Neilsen, associate professor of teaching.

The **Conservation Camp** held at Springbrook State Park, near Guthrie Center, will hold three sessions dealing with "Problems of Conservation." The sessions will run June 5-25, June 26-July 16, and July 17-August 6, and are under the direction of Dr. Verlin Lee, assistant professor of science.

The college will again participate in the **Lakeside Laboratory** at Lake Okoboji, which conducts two sessions of courses in fields of biology and botany. The laboratory is conducted jointly by the three state schools. The session will run from June 13 to July 17 and July 18 to August 19.

"Art in America" will be the theme of the **Art Tour** to be conducted by John Page, associate professor of art. The tour will visit some twenty-four museums, galleries, workshops, studios, and other points of interest, mostly in the

East. The tour will be open to twenty to twenty-five students for five hours credit, and will run June 13 to July 22.

The **Home Economics Communications Workshop**, June 13 to 24, will attempt to help junior and senior high school home economics teachers better interpret themselves and their goals to the public.

The **Art for Elementary Grades Workshop**, June 20 to July 1, is a 2-week course for two hours credit for elementary art teachers. The topic this summer will be 3-dimensional art.

The **Typewriting and Clerical Practice Workshop**, June 20 to July 1, will attempt to give high school business education teachers new ideas on instructional materials and teaching aids.

Elementary teachers and administrators will attend the **Elementary Curriculum Workshop** June 20-July 1 to study the elementary curriculum.

The **Elementary Leaders Workshop**, July 5-15, will deal with administrative problems for elementary principals and supervisors.

School district reorganization will be the topic of the **School Administration Workshop** July 18-29.

"Creative Learning" will be the topic of the **Public Relations Workshop**, July 10-13, which will be attended by civic leaders and schoolmen. The subject will stress the importance of encouraging creativity among students rather than mere amassing of facts.

Hawkeye Girls State, June 19-25, **Iowa High School Student Council** meeting, July 17-22, and the **Lutheran Service Conference**, July 24-29, will also make use of the college's facilities during the summer.
