The University Faculty Senate was called to order at 3:13 p.m. October 8, 1979, in the Board Room, by Chairperson Tarr.

Members of the press were requested to identify themselves. Barb Bush of the Northern Iowan was in attendance.

- 1. Correction to Senate Minutes #1252. On page 2, item 3, paragraph 3, line 7, after "position" add, "regarding the UNI degree. He indicated that the . . . "
- 2. Chairperson Tarr introduced Dr. Janice Abel to the Senate. Dr. Abel has been elected to fill the vacancy left by the resignation of former Senator Mr. Dennis Hendrickson.
- 3. Dr. Fred Lott, Assistant Vice President for Academic Affairs, rose and addressed the Senate. Dr. Lott indicated that representatives of the State Comptrollers Office were on campus. He indicated that matters under discussion included the funding of graduate assistantships, the School of Business, enrollment, Academic Computing Services, and budgeting and accounting procedures.
- Dr. Lott informed the Senate that the University is engaged in updating their reports to the Board of Regents concerning long-range academic planning. He indicated that materials are now being sent to departments for review and revision. He indicated that the materials primarily consist of a narrative in three parts: current programs, possible changes in current programs, and possible new additions to university programs in the future. The report also contains information regarding new staff members to the university, financial reports of the university, and long-range planning projections.
 - 4. Chairperson Tarr announced the following individuals have been elected to Chair their representative councils and/or committees: Professor Tom Remington, Graduate Council; Dr. Fred Lott, University Curriculum Committee; Professor J. Edelnant, Educational Policies Commission.

Chairperson Tarr indicated that he had received communication from the Educational Policies Commission inquiring as to how they were to discharge their responsibility with calendar item #243 (see Senate Minutes 1246). This calendar item was prompted by a letter from Professor Andrew Odell who is currently on leave from the University. M.B. Smith moved, Harrington seconded, that the Senate recommend to the Educational Policy Commission that they wait for the return of Professor Odell before proceeding further with this calendar item. Motion passed with two dissenting votes.

Dear John:

This is to notify you formally of actions taken by the University Faculty on October 1, 1979, in response to the Senate's request for consideration of representation by the School of Business on elected and appointed faculty committees.

Two specific amendments were made to the Faculty Constitution which result in satisfying the School of Business' proposal.

- 1. ARTICLE V; 2. (add at end of existing paragraph): The term "college" includes all academic units that function as a college, regardless of designation.
- 2. ARTICLE V; 3.1. (revised wording underlined): The University Faculty Senate shall be composed of twenty-one members.

These actions mean that both the School of Business and College of Social and Behavioral Sciences must conduct special elections or appointments where necessary to assure appropriate representation on the Senate as well as other Faculty committees. I know that Ed Rathmell, Chair, Committee on Committees, is assisting those units in identifying the vacant positions.

During the debate at the Faculty meeting, there was expression of interest in reviewing the composition of the University Senate. To facilitate such review, I would like the Senate to consider the following proposal that:

An <u>ad hoc</u> committee be formed to study the composition of the University Faculty Senate. The <u>ad hoc</u> committee should comprise one representative from each undergraduate 'college'

and one representative from the non-instructional faculty, all members to be selected by the Chairs of the Senate and Faculty.

The committee is asked to report its recommendations to the second Senate before the end of Fall semester, 1979.

I would appreciate having you bring this proposal to the Senate as soon as possible.

C: Council of Deans President Kamerick Marian Krogman, Chair, College of Social and Behavioral Sciences Council Vice President Martin Ed Rathmell, Chair, Committee on Committees Robert Waller, Director, School of Business Chairperson of the Faculty Harrington indicated that this letter was prompted by the concern of some faculty members on the apportionment of the faculty in relationship to membership on the Faculty Senate. J. F. Harrington moved, Thomson seconded, that: An Ad Hoc Committee be formed to study the composition of the University Faculty Senate. The Ad Hoc Committee should comprise one representative from each undergraduate "college" and one representative from the non-instructional faculty, all members to be selected by the Chairs of the Senate and Faculty. The Committee is asked to report its recommendations to the Senate before the end of Fall semester 1979.

Senator Gish inquired why the discussion should be limited to the University Senate and not such areas as the Curriculum Committee. Chairperson Tarr responded that this very concept has been addressed by the Committee on Committees which would bring material forth to the Senate.

Gish moved, Cawelti seconded, to amend by adding to the end of the first sentence: and all University Faculty committees that report to the Senate in conjunction with the Committee on Committees.

Senator Cawelti raised the question of conflict of interest concerning any current senators sitting on the Ad Hoc Committee and inquired if perhaps this project could be best handled by the Committee on Committees.

Chairperson of the Committee on Committees Rathmell indicated that the Committee felt the presence of members of the Senate would be helpful to this investigation, particularly those members who have knowledge of the history of the establishment of university committees.

Question was raised whether the motion was intended that the Senate be addressed first and the remaining University Committees later. The general response was that the action of the Faculty had dictated the composition of the Senate and that it was necessary to review all committees at the same time.

Question on the amendment was called. The motion to amend passed with one dissenting vote. Senator Cawelti again encouraged Chairpersons Tarr and Harrington to think of the possibility of conflict of interest when appointing members to this Ad Hoc Committee. Chairperson Harrington inquired if there was any objection to appointing former members of the Senate to this Ad Hoc Committee. No objections were raised.

Question on the main motion as amended was called. The motion as amended was passed.

The faculty action taken on Monday, October 1st, granted the School of Business full representation on the Faculty Senate. 3. The suggested ad-hoc committee that will be named to study and make recommendations about the composition of the Faculty Senate should also study and make recommendations about the composition and election procedures of all other Senate Committees.

Although these may appear to be stop-gap measures, I feel they will resolve the representation issue for the current year with some final resolutions coming from the report of the proposed ad-hoc committee.

Please know that I and the Committee on Committees will be willing to assist in any way that we can.

Questions were raised whether this item was being brought to the Senate under old or new business or as a potential calendar item. Chairperson Tarr responded that this correspondence was a follow-up to the last Senate meeting and the action recently taken by the University Faculty. He indicated he felt that the correspondence was timely and should be handled under new business. Senators expressed the willingness to review this item but indicated they would have preferred time to study it and did not wish to act on material without having adequate time to review and study the documents.

Wiederanders moved, Cawelti seconded, to place this item at the head of the docket out of regular order. Motion passed. Docket item 201.

M. B. Smith questioned the use of the words "or appoint" contained in line 2 of item 2. He questioned which body was to appoint these members.

Question was raised as to what is appropriate collegiate representation. Chairperson Rathmell indicated that appropriate representation meant equal to other "college" representation.

M. B. Smith moved, Gish seconded, to amend by striking in item 2, line 2, the words "or appoint." Motion to amend passed.

Schwarzenbach moved, Harrington seconded, to amend by striking in line 3 of item 2 the words "to one year terms of office" and to substitute with "for the 1979-80 academic year". Motion to amend passed.

Question was raised if this document contained all university committees that reported to the University Faculty Senate. It was mentioned that the Committee on Admission and Retention was missing and that it should be editorially added to this list.

Question was called on the motion as amended. The main motion as amended was passed.

I appreciated the opportunity to share with you in a consultative session what I believe to be a serious problem for UNI students due to the present policy of allowing five working days before final grades are due from the faculty.

The calendar for the Fall semester 1979 points out the problem areas:

End of Final Exams
Final grades due from Faculty
Registration for Spring 1980 semester
Class begins Spring 1980 semester

Friday, December 21, 1979 5:00 p.m. Thurs., Jan. 3, 1980 Monday, January 14, 1980 Tuesday, January 15, 1980

The earliest grade reports could be received from the Data Processing Service would be Monday, January 7, for students who graduated December 21 and Tuesday, January 8, for all other students. Graduation must be verified and transcripts prepared before official notice of graduation is made. This delays students requesting a teaching certificate or having credentials sent to prospective employers.

The Admission and Retention Committee cannot meet until grade reports are available. The earliest they could meet would be Wednesday, January 10. Students who are suspended must be notified they should not return to the campus for the start of the spring semester.

I am recommending for your consideration the following proposal:

Effective with the Fall semester 1979 final grades are to be due from the faculty in the Fall and Spring semesters no later than 1:00 p.m. on the third day following the end of the final examination period excluding Saturday, Sunday, and legal holidays when the University is officially closed. Final grades at the end of the summer session will be due at 1:00 p.m. two days after the close of the summer session exclusive of Saturday, Sunday, or legal holidays when the University is officially closed.

Fall 1979

Friday, December 21, 1979

Summer 1980

Friday, August 1, 1980

Tuesday, August 5, 1980

While this proposal reduces the number of days allowed the faculty before grades are due, the majority of faculty already turn in their grades prior to the due date. Efficiency as well as economy dictate that grades be computer processed at the same time. Grades are therefore processed based on the last grades submitted or the due date.

I request the Senate's approval of this proposal. If approved, the Registrar's Office will notify the Faculty of the change in the date grades are due for the current semester.

M. B. Smith moved, Geadelmann seconded, the adoption of the docketed item as described.

Question was raised whether the Senate felt adequate time had been given for their colleagues to be aware of this communication. This communication is a product of the consultative session Registrar Leahy had with the University Faculty Senate on September 24, 1979. Some senators spoke to delaying action on this matter until their constituents had an opportunity to voice their opinions to their representatives.

M. B. Smith moved, Cawelti seconded, to adjourn. Motion passed. The Senate adjourned at 3:59 p.m.
